- 1) Call to Order: The meeting was called to order at 7:30pm by Rich Bentley.
- 2) Presentation with NYS Assemblyman Anthony D'Urso: GC discussed with Assemblyman D'Urso: NYS funding assistance to help fund a feasibility study with regard to waste water treatment for Manhasset's Plandome Rd commercial area. Q&A on proposed MedMen medical marijuana facility. Will need variance for parking. NYS DOH only establishes number of dispensaries in each county. Beyond that no regulatory involvement; Need NYS help/ assistance to develop and impose greater facility location restrictions in neighborhoods for medical marijuana dispensaries. Assemblyman D'Urso expressed ssteadfast support in these matters.
- 3) Presentation and Discussion with MedMen on 1575 Northern Blvd application. Powerpoint presentation by MedMen available on GC website (link). MedMen is publicly traded. CSE: MMEN. MedMen reports that 62% of patients using their current Lake Success location are from Manhasset and Great Neck and that the move to Manhasset is to make location more convenient for patients. Marijuana in store is in vault, not on display. Only card holders may enter - tours require a certain ratio of security and staff; and welcome members to visit. MedMen is one of ten companies in NY. Each company is allowed 4 locations within NYS as per NY law and require dispensaries be spread out. MedMen wants to be good neighbor with community and work collaboratively with transparency, and communicate directly with local law enforcement. Compliant driven. Rich Bentley noted he spoke with NCPD 3rd Precinct Commanding Officer who was unaware of any Pct interaction with MedMen. The application is in to TNH Bldg Dept for building permit; no action taken yet, but variance for parking is expected to be necessary. Retail requires 1 for every 300 sf after the first 1000sf. Building dept is requiring this as medical office but MedMen is looking to get this recognized as retail use, "more like an eyeglass store." Lake Success is classified as medical facility. Syracuse and Buffalo are in retail locations. Andrew Schwenk asked how the store would change if recreational use is legalized. Best comparison is Beverly Hills store. 75 customers a day when medical went to 250 customers per day when recreational. Adult use limits the amount you can buy. Must be 21 and show ID to get in, and cannot go over a certain limit to purchase even recreational products. NYS is the most highly regulated state for medical use.

MedMen claims to exceed NYS requirements using at least two security guards 24-7. . Hours of operation 10am-8pm. Assemblyman D'Urso asks why so much security as it is far more than pharmacies where opiods and narcotics are dispsensed. MedMen responded because they want to be good neighbors. Prevent loitering, theft, use on premises. Enhanced security also because of cash and products. Cannot accept credit cards. Lake Success: Was 10-12 patients per day, now 50-60 patients. Does not anticipate variety of products that are available in CA will be allowed in NYS. Anticipate 60-75 per day in new location. Average visit = 7 minutes. Andrew Schwenk asked if traffic study is being done for location.
